## **RULES FOR DRIVING EVENTS 2016**

- 1. VEHICLES MUST BE EITHER LAWFULLY ROAD REGISTERED WITHIN A STATE OR TERRITORY OF AUSTRALIA OR BE APPROVED BY THE SANCTIONED CLUB'S APPOINTED SCRUTINEER AS BEING OF ROAD WORTHY CONDITION OR OF BEING SAFE FOR THE PURPOSE OF THE EVENT, AN ADDITIONAL SANCTION FEE APPLIES TO EVENTS WHERE UNREGISTERED CARS ARE ALLOWED TO PARTICIPATE. ALTERNATIVELY, UNREGISTERED VEHICLES MAYBE REQUIRED TO PROVIDE PROOF OF THEIR OWN PUBLIC LIABILITY INSURANCE.
- 2. ALL OWNERS, DRIVERS, PASSENGERS AND OFFICIALS MUST FILL OUT THE DRIVING EVENTS DECLARATION FORM AND CONFIRM THAT THEY ARE ADULTS BY PROOF OF IDENTITY. MINORS CANNOT BE OFFICIALS, DRIVERS OR PASSENGERS IN CARS (SEE 10 UNDER)
- 3. ALL VEHICLES MUST HAVE EFFECTIVE TAIL SHAFT LOOPS OR SIMILAR DEVICES FITTED TO THE SATISFACTION OF THE SCRUTINEER(S) APPOINTED BY THE CLUB. WHERE THE CARS COSNTRUCTION PROVIDES FOR AN EFFECTIVE TAIL SHAFT LOOP SUCH AS CORSS MEMBERS ETC THESE MAY SUBJECT TO SCRUTINEERING BE ACCEPTABLE FOR THE PURPOSE.
- 4. ALL WHEEL BALANCE WEIGHTS AND VALVE CAPS MUST BE REMOVED.
- 5. SUPERCHARGED VEHICLES MUST HAVE METAL BELT GUARDS ON SUPERCHARGER BELT
- 6. THE BURNOUT TRACK MUST BE ENCLOSED BY AT LEAST A 2.4 METRE (8 FT) HIGH CHAIN WIRE FENCE AND IMMEDIATELY INSIDE THAT FENCE HAVE AN ARMCO STYLE RAILING OR NEW JERSEY KERB STYLE WATER FILLED BARRIERS SURROUNDING THE BURNOUT PAD. ALTERNATIVELY LARGE RUN OFF AREAS ARE TO BE RPOVIDED SUBJECT TO THE PROVSION OF A SUITABLE AREA ENCLOSED BY ARMCO STYLE RAILING OR NEW JERSEY KERB STYLE WATER FILLED BARRIERS FOR THE PROTETCION OF OFFICIALS AND FIRE MARSHALS. ALL SPECTATOR AREAS ARE TO BE PROTETCED BY THE USE OF SUITABLE BARRIERS.
- 7. THE GO-WHOA, MOTORKHANA, CHUKA SPUD COURSE IS TO BE LAID OUT WITH ADEQUATE RUN OFF AND OVERRUN AREAS THAT ALLOW FOR SUFFICIENT SEPARATION FROM THE AREAS WHERE SPECTATORS ARE TO BE ALLOWED. OFFICIALS TIMING OR OBSERVATION AREAS ARE TO BE ENCLOSED BY NEW JERSEY KERB STYLE WATER FILLED BARRIERS OR SIMILAR DEVICES.
- 8. OFFICIALS WORKING NEAR THE EVENTS MUST WEAR HEAD PROTECTION WITH A CLEAR FULL FACE VISOR, EAR PROTECTION, BODY PROTECTION (BOILER SUIT TYPE OVERALLS) AND WEAR BRIGHTLY COLOURED SAFETY VESTS. OFFICIALS ON THE TRACK MUST WEAR LEATHER GLOVES.



- 9. EVENTS MUST BE STARTED AND FINISHED BY THE WAVING OF A HIGHLY VISIBLE FLAG ABLE TO BE OBSERVED BY DRIVERS, i.e. GREEN FLAG TO START RED OR CHEQUERED FLAG TO FINISH.
- 10. DRIVERS MUST WEAR LONG SLEAVE COTTON SHIRTS AND LONG TROUSERS OR EQUIVALENT, APPROVED CRASH HELMET AND SEATBELTS. APPLIES TO PASSENGERS IF ALLOWED. NOTE CHILDREN UNDER THE AGE OF 16 ARE NOT PERMITTED AS PASSENGERS WITHIN COMPETING VEHICLES.
- 11. ALL VEHICLES MUST HAVE BONNETS ATTACHED WHERE FITTED AS STANDARD EQUIPMENT. EXCEPTIONS SEE BELOW\*\*\*\*\*\*\*\*
- 12. BONNETS MUST BE REMOVED ON METHANOL OR ALCOHOL BASED FUELED CARS SO THAT ANY FIRE IN THE ENGINE BAY MAY BE MORE VISIBLE TO SAFETY AND FIRE MARSHALS. WATER IS RECOMMEDMED AS THE BEST FIRE RETARDENT FOR SUCH FUELS.
- 13. SUITABLE FIRE FIGHTING EXTINGUISHERS MUST BE AVAILABLE AND FUNCTIONAL CLOSE AT HAND FOR USE BY OFFICIALS IN THE EVENT OF FIRE. IN THE EVENT THAT FIRE EXTINGUISHERS ARE DISCHARGED AS A RESULT OF FIRE THE DISCHARGED UNITS ARE TO BE REPLACED WITH FULLY CHARGED EXTINGUISHERS BEFORE THE EVENTS CONTINUE.
- 14. ANY DISABLED VEHICLES ON THE COURSE ARE TO BE REMOVED PRIOR TO THE NEXT VEHICLE ENTERING THE COURSE.
- 15. ANY DISBALED CAR THAT IS ORDERED TO STOP DURING THE EVENT MUST ONLY BE RESTARED AFTER ALL SAFETY AND FIRE PERSONNEL ARE OFF THE COURSE OR PAD.
